## **Tales of the Jazz Age**

In her exhaustive publishing history of Frances Burney's *Cecilia, Or Memoirs of an Heiress*, Catherine Parisian mines an extensive archival record that includes portions of the original manuscript, annotated page proofs, legal records relative to its copyright, and an abundance of letters, to chronicle the novel's composition, printing, and publication from its first edition in 1782 to the present-day Oxford World's Classics paperback. ## **The Golden Ass**

*Plutos* is generally regarded as the dull capstone of Aristophanes' illustrious career and of a genre that has long since left its heyday behind. The present work revises this negative judgement. Through a comprehensive analysis of the historical and cultural background of the play, it demonstrates that the theme of money dealt with in *Plutos* was highly topical for the Athenian audience of 388 BC. Drawing on modern theories, the author examines the comedy of the play and analyses it not only scene by scene, but also with a view to the whole. A comic plot is worked out that is not only characteristic of *Pluto*, but of every comedy by Aristophanes. The mode of action of comedy in Old Comedy is thus described in a fundamentally new way

and the understanding of the genre in this respect is placed on a new foundation. The reinterpretation of Pluto proves the play to be a direct critique of the times in the tradition of 5th century Old Comedy.

## **Frances Burney's Cecilia**

An exploration of the serialization of children's classics by contemporary publishers, this book digs into the impact of the practice and provides new ways of reading the corpus of British children's literature from the 20th century. Amy Webster demonstrates how publishers select texts for their series, which texts they omit, which outliers are sometimes included and how a core group of works from the golden age of children's literature emerged. The text also examines how texts are abridged and transformed from publisher to publisher through close readings of *The Wind in the Willows* and *Alice's Adventures in Wonderland*; and how the repackaging of works within a series highlight issues and choices tied to key paratextual elements. Analysing data through distant reading and close reading of series from Ladybird, Longman, Puffin and Walker Illustrated editions, this book sheds light on how modern classics series are marked by variation and instability but also a reductive homogeneity. Through her use of quantitative and text-focused research, Webster reveals how commercial motivations have created a gulf between the canonical concepts of the classic and how the term functions as a marketing tool in British children's publishing. With notions of what counts as a classic compromised and complicated, this book leads the call for a critical approach towards both the term 'classic' and to reading children's classics that acknowledges how they are tied to the commercial enterprises of the children's book business.

## **Boris Godunov and Other Dramatic Works**

Damit trägt dieses Buch insbesondere zur seit Jahrzehnten schwelenden Debatte darüber bei, inwieweit es im Römischen Reich sozialen Druck zur kulturellen Anpassung gegeben habe – oder sogar so etwas wie eine entsprechende Kulturpolitik. Das Buch richtet sich so nicht nur an ein althistorisches Fachpublikum, sondern ebenso an Historiker/-innen anderer Epochen, Altertumswissenschaftler/-innen anderer Disziplinen sowie Kultur- und Literaturwissenschaftler/-innen. Wegen des hochaktuellen Themas – der Debatte um kulturelle Anpassung bzw. Integration – kann es zugleich aber auch für eine breitere Öffentlichkeit von Interesse sein.

## **The Fin-de-Siècle World**

Participatory governance has a long history in India and this book traces historical-intellectual trajectories of participatory governance and how older Western discourses have influenced Indian policymakers. While colonial rulers devolved power to accommodate dissenting voices, for independent India, participatory governance was a design for democratizing governance in its true sense. Participation also acted as a vehicle for localizing governance. The author draws on both Western and non-Western theoretical treatises and the book seeks to conceptualize localizing governance also as a contextual response. It also makes the argument that despite being located in different socio-economic and political milieu, thinkers converge to appreciate localizing governance as perhaps the only reliable means to democratize governance. The book aims to confirm this argument by reference to sets of evidence from the Indian experience of localizing governance. By attempting a genealogy of participatory governance in the West and in India, and an empirical study of participatory governance in India, the book sheds light on the exchange of ideas and concepts through space and time, thus adding to the growing body of literature in the social sciences on 'conceptual flow'. It will be of interest to political scientists and historians, in particularly those studying South Asia.

Dieser Sammelband widmet sich den römischen Epikern Lucan, Valerius Flaccus, Statius und Silius Italicus. Die Beiträge beleuchten den Kontrast zwischen Gattungstheorie und -praxis, das Zusammenspiel von Gattungsinterferenzen und Intertextualität sowie das Spannungsverhältnis zwischen Konvention und Innovation. Im Mittelpunkt steht das Verhältnis der nachaugusteischen Epik zur früheren Tradition, d. h. zu maßgeblichen Vorgängern wie Homer, Vergil und Ovid. ## **The Complete Writings**

Das hier in neuer Auflage vorgelegte Repertorium soll dazu dienen, zwei Grundproblemen der mediävistischen Forschung zu beheben: Diese Epoche des Denkens war von gewaltiger Produktivität gekennzeichnet, deren Überlieferung in vielfältiger Weise mit Schwierigkeiten behaftet ist. Die Überlieferung ist nicht nur in hohem Maße eine handschriftliche, sondern auch äußerst lückenhaft und von vielen Wissensverlusten, etwa bezüglich der Autorschaft, betroffen. Da seit dem 19. Jahrhundert viele der Texte nur in Auszügen ediert worden sind, finden sich Teiltexthe aus demselben Werk oft an vielen Orten. Dieser Unübersichtlichkeit versucht das Repertorium Abhilfe zu schaffen. Die aufgenommenen bibliographischen Angaben sind gegenüber der ersten Auflage erheblich erweitert: die neue Auflage erfasst jetzt nahezu 40.000 Editionen von über 2.300 Autoren. Nach systematischen Gesichtspunkten geordnet sind zusätzlich weit über 1000 anonyme Texte berücksichtigt worden. Dabei sind bei Autoren, deren Werk in einer Gesamtausgabe publiziert worden ist, regelrechte Konkordanzen entstanden. Ebenso wie bereits bei der ersten Auflage wurden auch ein- oder zweisprachige Übersetzungsausgaben berücksichtigt. Zur leichteren Identifizierbarkeit sind die Autoren mit einigen biographischen Angaben versehen. Der Benutzer findet bei

nahezu jedem Autor eine Liste aller Werke, die ganz oder in Auszügen ediert worden sind. Mehrere Indices – Autoren, Editoren und Übersetzer, Incipits, Manuskripte, Kommentare – erschließen das Nachschlagewerk.
